# ARTICLES OF INCORPORATION OF BISHOP CAPITAL MANAGEMENT, INC.

#### ARTICLE I. NAME AND ADDRESS

The name of the Corporation is BISHOP CAPITAL MANAGEMENT, INC. ("Corporation"). The principal and mailing address of the Corporation is 239 South County Road, Suite 300, Palm Beach, Florida 33480.

### ARTICLE II. PURPOSES

#### ARTICLE III. POWERS

### ARTICLE VI. BOARD OF DIRECTORS

6.1. The business and affairs of this Corporation shall be managed by a Board of Directors, whose members are referred to herein as Directors.

- 6.2. The Directors of the Corporation shall be selected from among those individuals who have an interest and who possess the ability to participate effectively in the discharge of the responsibilities of the Board of Directors. The Directors of the Corporation shall be elected for terms and in the manner provided in the By-Laws from time to time.

## ARTICLE VII. OFFICERS
