ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.**

The name of this corporation is **ROBERT A. HIRSCH, M.D., P.A.**

2. **Duration.**

The period of its duration is perpetual.

3. **Nature of Business.**

The nature of the business to be transacted by the corporation is to engage in the practice of medicine and to exercise the powers now or hereafter granted to professional service corporations under the laws of the State of Florida.

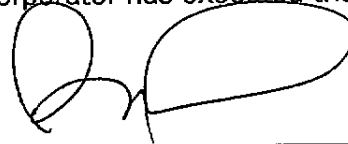

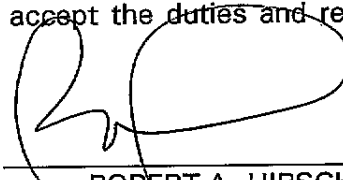

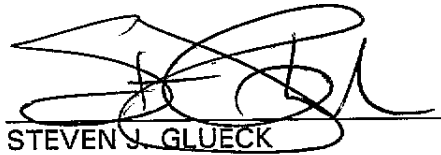
