The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby for a Corporation for profit under Chapter 607 of the Florida Statutes.

#### **ARTICLE 1 - NAME**

The name of the Corporation is BESTCOVERAGE.COM, INC.

#### ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office of this Corporation is 320 GREEN OAK COURT, LONGWOOD, FLORIDA 32779 and the mailing address is the same.

#### ARTICLE 4 - INCORPORATOR

#### ARTICLE 5 - PRESIDENT

The initial President of the Corporation shall be PATRICK N. PREDDY whose address shall be the same as the principal office of the Corporation.

The shares of stock represented by this certificate cannot be transferred if such transfer would void the election of The Corporation to be taxed under Sub-chapter S of the Internal Revenue Code of 1986, as amended."

### ARTICLE 8 - POWERS OF CORPORATION

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.

### ARTICLE 9 - TERM OF EXISTENCE
