

**ARTICLES OF INCORPORATION  
OF  
INDUSTRIAL TAILOR, INC.**

The undersigned incorporators, intending to form a corporation under the Florida Business Corporation Act (Chapter 607 F.S.) hereby adopts the following Articles of Incorporation:

**ARTICLE I.** The name of the Corporation is Industrial Tailor, Inc.

**ARTICLE II.** The principle place of business and mailing address of the Corporation's initial registered office is 2825 St. Augustine Drive, Orlando, FL 32825.

**ARTICLE III.** The Corporation shall have the authority to issue 10,000 shares of common stock, par value one cent (\$.01) per share. The holders of common stock shall have one vote per share and shall not be entitled to cumulate their votes in the election of directors.

**ARTICLE IV.** The name and street address of the initial registered agent are: Michael Garlick, 2825 St. Augustine Drive, Orlando, FL 32825.

**ARTICLE V.** The name and address of each incorporator is:

**ARTICLE VI.** A director of the Corporation shall not be personally liable for monetary damages for any action taken, or failure to take any action unless the director has breached or failed to perform the duties of his or her office set forth in §607.0831 of the Florida Business Corporation Act, as it may be amended, and such breach or failure to perform constitutes self-dealing, willful misconduct or recklessness; provided, however, that the foregoing provision shall not eliminate or limit (i) the responsibility or liability of a director under any criminal statute, or (ii) the liability of a director for the payment of taxes under local, state or federal law. Any repeal, modification or adoption of any provision inconsistent this Article VI, shall be prospective only, and neither the repeal or modification of this Article nor the adoption of any provision inconsistent with this Article shall adversely affect any limitation on the personal liability of a director of the Corporation existing at the time of such repeal or modification or the adoption of such inconsistent provision.
