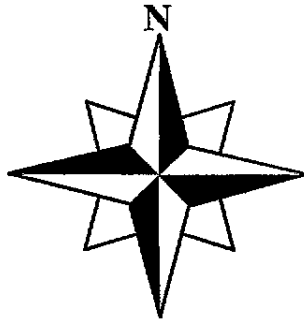

**ARTICLES OF INCORPORATION
OF
DUPOTY TRUCKING CORP.**

The undersigned subscribers to these ARTICLES OF INCORPORATION are natural persons competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the corporation is Dupotey Trucking Corp.

ARTICLE 2 - PURPOSE OF CORPORATION

The corporation shall engage in any activity or business permitted under the laws of the UNITED STATES and the STATE OF FLORIDA.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office is 2730 W. 76 Street Hialeah, Florida 33016

ARTICLE 4 - INCORPORATORS

The name and street address of the Incorporator is Alejandro Dupotey 2730 W. 76 Street Hialeah, Florida 33016

ARTICLE 5 - BOARD OF DIRECTORS

The initial Board of Directors of the Corporation shall be Alejandro Dupotey, President, whose address shall be the same as the principal office of the corporation.

ARTICLE 6 - CORPORATE CAPITALIZATION

6.1 The maximum numbers of shares that this corporation is authorized to have outstanding at any time is FIVE HUNDRED of COMMON SHARES; each share having the par value of ONE DOLLAR (\$ 1.00).

6.2 No holder of shares of stock of any class shall have any preemptive right to subscribe to or purchase any additional shares of any class, or any bonds or convertible securities of any nature, however, that the Board of Directors may, in authorizing the issuance of shares of stock of any class, confer any preemptive right that the Board of Directors may deem advisable in connection with such issuance.

6.3 The Board of Directors of the corporation may authorize the issuance from time to time of shares of its stock of any class, whether now or hereafter authorized, or securities convertible into shares of its stock of any class, whether now or hereafter authorized, for such consideration as the Board of Directors may deem advisable subject to such restrictions or limitations, if any, as may be set forth in the by-laws of the Corporation.

6.4 The Board of Directors of the corporation may, by articles supplementary classify or reclassify any unused stock from time by setting or changing the preference, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

ARTICLE 7 - SUB-CHAPTER 'S' CORPORATION
--

The corporation may elect to be an "S" Corporation, as provided in Sub-Chapter "S" of the Internal Revenue Code of 1986, as amended.

7.1 The Shareholders of this corporation may elect and, is elected, shall continue such election to be an "S" Corporation as provided in Sub-Chapter "S" of the Internal Revenue Code of 1986, as amended, unless the shareholders of the corporation unanimously agree otherwise in writing.

7.2 After this corporation has elected to be an "S" Corporation, none of the Shareholders of this corporation, without written consent of the other Shareholders of this corporation shall take any action, or make any transfer or other disposition of the Shareholders Shares of stock in the corporation, which will result in the termination or revocation of such election to be an "S" corporation, as provided in Sub-Chapter "S" Corporation, of the Internal Revenue Code of 1986, as amended.

7.3 Once the corporation has elected to be an "S" Corporation, each share of Stock issued by this corporation shall contain the following legend.

"The shares of stock represent by this Certificate cannot be transferred I such transfer would be taxed under Sub-Chapter "S" of the Internal Revenue Code of 1986, as amended.

ARTICLE 8 - POWERS OF CORPORATION

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restrictions imposed by applicable law or these ARTICLES OF INCORPORATION.

ARTICLE 9 - TERM OF EXISTENCE

The Corporation shall have perpetual existence.

ARTICLE 10 - TITLE

The corporation, to the extent permitted by the by-laws, shall be entitled to treat the person whose name any share or right is registered on the books of the corporation as the owner thereto. for all purposes, and shall not be bound to recognize any equitable or other claim to. or interested in, such share or right on the part of any other person, whether or not the Corporation shall have notice thereof.

**ARTICLE 11 - REGISTERED OFFICE AND
REGISTERED AGENT**

The initial address of the Registered Office of this corporation is 2730 W. 76 Street Hialeah, Florida 33016. The name and address of the initial Registered is Alejandro Dupotey.

In pursuance of Chapter 43.091, Florida Statutes, the following is submitted in compliance with said act.

First, Dupotey Trucking Corp. desiring to form a corporation under the laws of the State of Florida with its principal office as indicated in the Articles of Incorporation, at the city of Miami, Florida, County of Dade, has designated Alejandro Dupotey as its agent to accept service of process within this State. Having been named to accept service of process for the above stated corporation, at the place designated in this Certificate, I hereby accept to act in this capacity, and agree to comply with the provision of said act relative to keeping open said office.

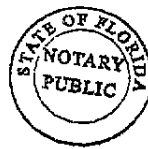
