The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is RAINBOW THIN FILM CORPORATION.

ARTICLE II - PRINCIPAL OFFICE/MAILING ADDRESS
