

1. The name of the corporation shall be: Carmel Collision Center, Inc.
2. The principal place of business and mailing address of this corporation is: 309 Carmel Dr., Fort Walton Beach, FL 32547.
3. The corporation shall have the authority to issue 100 shares of stock.
4. The registered agent of the corporation is Mary Ann McCarthy and the registered street address is 309 Carmel Dr., Fort Walton Beach, FL 32547.
5. The business of this corporation shall be managed by its stockholders rather than by a Board of Directors. In the management of the business of the corporation, the act of the stockholders representing a majority of the outstanding shares of the corporation entitled to vote, represented in person or proxy, shall be the act of the stockholders.
