

## ARTICLES OF INCORPORATION

OF

- 1. The name of the corporation shall be: Carmel Collision Center, inc. 9
- The principal place of business and mailing address of this corporation
   309 Carmel Dr., Fort Walton Beach, FL 32547.
  - 3. The corporation shall have the authority to issue 100 shares of stock.
