## ARTICLES OF INCORPORATION

of

## Article I -- Name

The name of this corporation is ROSEMARIE'S KITCHEN, INC.

# Article II -- Duration

This corporation shall exist for a perpetual period of time.

## Article III -- Purpose

This corporation is organized for the purpose of operating a restaurant and/or sub shop, and transacting any and all business which may be permitted under the laws of the State of Florida, and approved by the Board of Directors.

#### Article IV -- Capital Stock

This corporation is authorized to issue 100 shares of common stock at ten (\$10.00) dollar par value.
