**ARTICLE I - Vintage Management Group , Inc.**

The name of this Corporation is **Vintage Management Group , Inc.**

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**




