

ARTICLES OF INCORPORATION

OF

SUBMERGED VISIONS, INC.

The undersigned incorporators to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Florida and hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: **SUBMERGED VISIONS, INC.**

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

(a) To engage in the general business, including but not limited to the teaching of scuba diving skills and related diver education and training activities, and any other things necessary in the full and complete operation thereof, and further,

(b) To engage in any artistic, commercial, industrial, and educational enterprise calculated or designed to be profitable to this corporation.

(c) To generally engage in, do and perform, any enterprise, act, or vocation that a natural person might or could do or perform;

(d) To engage in the manufacture, sale, purchase, importing, and exporting of merchandise and personal property of all manner and description, to act as agents for the purchase, sale, and handling of goods, wares, and merchandise of any and all types and descriptions for the account of the corporation or as factor, agent, procurer, or otherwise for or on behalf of another.

(e) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure payment of corporate indebtedness as required.

The foregoing paragraphs shall be construed as enumeration both objects and powers of the corporation; and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

ARTICLE III - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding

at any one time is **five hundred (500)** shares of common stock, having a no par value per share.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is **Five Hundred Dollars (\$500.00)**.

ARTICLE V - TERM OF EXISTENCE

The term of existence of this corporation shall be perpetual.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT


