I, the undersigned sole subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby endeavor to establish a Florida corporation for profit.

ARTICLE I

The name of this Corporation is S. W. TITLE, INC.

ARTICLE II

This Corporation is organized for the purpose of engaging in any or all lawful business permitted under the laws of the State of Florida.

ARTICLE III

The maximum authorized capital stock of this Corporation shall be One Thousand Shares (1,000) of common stock with a par value of One Dollar (\$1.00).

ARTICLE VI


The sole incorporator is SUZANNE WILSON.






