#### ARTICLES OF INCORPORATION

## DOMESTIC VIOLENCE DEFENDERS, P.A.

The undersigned subscribed to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the Laws of the State of Florida.

#### **ARTICLE I - NAME AND ADDRESS**

The name of this Corporation shall be **DOMESTIC VIOLENCE DEFENDERS**, **P.A.**, and its initial principal place of business will be at 1200 Brickell Avenue, Suite 1680, Miami, Florida 33131-3257.

#### ARTICLE II - NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the Laws of the State of Florida and of the United States of America; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, mutual life insurance association, cooperative association, fraternal benefits society, state fair or exposition. The specific purpose of the Corporation shall be for the Practice of Law.

#### ARTICLE III - SHARES OF STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares at \$1.00 par value.

#### **ARTICLE IV - DURATION**

The Corporation is to have perpetual existence, commencing upon the filing of these Articles with the Department of State.

### **ARTICLE X - AMENDMENTS**

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at the stockholders' meeting by a majority of the stockholders entitled to vote thereon, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of

Incorporation be made.

# **ARTICLE XI - REGULATION OF BUSINESS**

The following additional provisions are inserted for the management of the business and for the conduct of affairs of the Corporation, and to create, define, limit, and regulate the powers of the Corporation, and the shareholders:

- A. If the By-Laws of the Corporation so provide, any meeting of the shareholders may be held within or without the State of Florida and the books and records of the Corporation may be kept at such place or places outside the State of Florida as may be designated, at any time, or from time to time, by the shareholders, unless otherwise provided by the laws of the State of Florida.
- B. No contract or other transaction between the Corporation and one or more of its shareholders, or any other corporation, firm, association, or entity in which one or more of its share-holders are directors or officers, or are financially interested, shall be either void or voidable because of such relationship or interest or because of such shareholder or shareholders are present at the meeting which authorizes, approves, or ratifies such con- tract or transaction or because his or their wishes are counted for such purpose if:

The fact of such relationship or interest is disclosed or known to the shareholders who authorize, approve, and ratify the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of such interested shareholder or shareholders; or

The fact of such relationship or interest is disclosed or known to the shareholders entitled to vote and they authorize, approve, and ratify such contract or transaction by vote or written consent; or

The contract or transaction is fair and reasonable as to the Corporation at the time it is authorized by the shareholders.

Such common or interested shareholders may be counted in determining the presence of a quorum at a meeting of the shareholders, which authorizes, approves, and ratifies such contract or transaction.

- C. The stock of the Corporation is issued pursuant to the provisions of section 1244 of the Internal Revenue Code.
- D. In the event a certificate of stock is lost, stolen, or destroyed, the Corporation may issue a replacement certificate without requiring the surrender of the certificate or cancellation, provided that the shareholder in whose name the certificate was registered shall provide an affidavit setting forth the circumstances under which such certificate was lost, stolen, or destroyed and provided said shareholder agrees in writing to indemnify and hold the Corporation harmless from and against any and all claims, actions, and suits whether groundless or otherwise and from and against any and all liabilities, losses, damages, costs, charges, counsel fees, and other expenses, of every nature and character, which the Corporation at any time shall or may sustain or incur by reason of any claim or demand which may be made as a result of the issuance of such new certificate.
- E. The Corporation and the holders of a majority or more of the shares of the Corporation shall have the power to enter into an agreement restricting or limiting the sale, transfer, assignment, pledge, or hypothecation of the shares of the Corporation or any part thereof. If at any time the holder of a majority or more of the shares of the Corporation shall enter into an agreement restricting or limiting the sale, transfer, assignment, pledge, or hypothecation of the shares of the Corporation or any part thereof to which agreement the Corporation shall become a party, the Corporation shall thereupon observe and carry out on its part the terms of any such agreement and shall refuse to recognize any sale, transfer, assignment, pledge or hypothecation of any of the shares covered by such agreement, unless the same be in conformity with the terms and conditions of such agreement provided that a copy of such agreement be filed in the principal office of the

Corporation, and provided further that notice of the existence of such provision be note conspicuously on the face and back of each and every certificate of shares subject to the terms and conditions of any such agreement.

The Corporation reserves the right to amend, alter, change, or repeal any or F. all of the provisions contained in this Articles of Incorporation, in the manner now or thereafter prescribed by statute, and all right conferred upon shareholders herein are granted subject to this reservation.

## ARTICLE XII - PREEMPTIVE RIGHT

Every stockholder shall on the sale for cash of any new stock of the same class as that which he already holds, have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
