**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **ARLENE R. MARTONE, M.D., P.A.**

ARTICLE II

The existence of the corporation shall begin on the date of filing and be perpetual.

ARTICLE III
