ARTICLE ONE

NAME

DURATION

This corporation shall have perpetual existence.

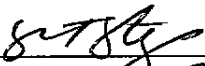

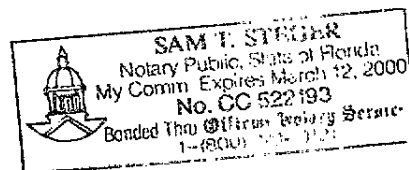
