

# ARTICLES OF INCORPORATION OF SARNER CONSULTING, INC.



The undersigned, acting as incorporator of SARNER CONSULTING, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be SARNER CONSULTING, INC.

#### ARTICLE II - EXISTENCE

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.
