**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of SARNER CONSULTING, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be **SARNER CONSULTING, INC.**

ARTICLE II - EXISTENCE

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III - ADDRESS

The principal business address of this corporation shall be: 5424 NW 41st Terrace, Boca Raton, Florida, 33496.

ARTICLE IV - PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V - SHARES


ARTICLE IX - BYLAWS
