The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607, Fla. Stat., The Florida Business Corporation Act, hereby states the following:

ARTICLE I - NAME

The name of the Corporation shall be del Cuadro & De Los SantosJR., IW. The initial mailing address of the Corporation shall be 14550 Bruce B. Downs, Bldg. #1, Apt. #7, Tampa, FL 33613.

ARTICLE II - DURATION

Corporation shall have perpetual existence The beginning on the filing date of these Articles.

ARTICLE III - PURPOSE AND POWERS
