## **ARTICLES OF INCORPORATION**

**OF**

### **SINGLETON ALLIED MAINTENANCE CO., INC.**

The undersigned subscriber to these Articles of Incorporation, a person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### **ARTICLE I**

The name of this corporation is: SINGLETON ALLIED MAINTENANCE CO., INC.

#### ARTICLE VII






