I, the undersigned incorporator, do hereby form a corporation for profit under the General Laws of the State of Florida, and pursuant to §607.0202, Florida Statutes, these articles of incorporation provide that:

# ARTICLE I

The name of the corporation shall be MONTE PALMA CIGARS, INC.

# ARTICLE II

The location of the principal place of business shall be 113 Stirrup Key Woods Road, Apt. 3 B2, Marathon, Florida. The mailing address of this corporation shall be 113 Stirrup Key Woods Road, Apt. 3 B2, Marathon, Florida, 33050.

# ARTICLE III

The corporation shall have perpetual existence.

# ARTICLE IV

# ARTICLE V

The general nature of the business to be transacted shall be the following:

1.
