ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Article of Incorporation:

ARTICLE I

Name

The name of this corporation is: **Rest Assure Janitorial Service, Inc**

ARTICLE II

Duration

This corporation shall have a perpetual existence, commencing on the date these Articles are filed with the Secretary of State.

ARTICLE III

Purposes

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporations Code.

ARTICLE IV

Capital Stock

This corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock, \$1.00 par value; and the total number of shares which this corporation is authorized to issue is 2000.

ARTICLE V

Resident Agent

Pursuant to Chapter 48.901, Florida Statutes, and in compliance with said Act, Raymond Malave is hereby designated as the corporation's agent to accept service of process within the State of Florida.

ARTICLE VII

Directors Liability

(a) The liability of directors of this corporation for monetary damages shall be eliminated to the fullest extent permissible under the Florida Business Corporation Act.

(b) This corporation is authorized to provide indemnification of agents (as defined in the Florida Business Corporations Act) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors, or otherwise, to the fullest extent permissible under Florida law.

(c) Any amendment, repeal or modification of any provision of this Article V shall not adversely affect any right or protection of an agent of this corporation existing at the time of such amendment, repeal or modification.

ARTICLE VIII

Initial Board of Directors

This corporation shall initially have two Directors. The number of directors may be either increase or diminished from time to time by the By-Laws of this corporation, but shall never be less than one (1).
