ARTICLES OF INCORPORATION

OF

MOVING SOLUTIONS, INC.

ARTICLE I NAME

The name of this corporation is **MOVING SOLUTIONS**, **INC**.

ARTICLE II DURATION

This corporation shall have perpetual existence, commencing on the date of filing of these Articles with the Secretary of State of the State of Florida.

ARTICLE III PURPOSE

This corporation is organized for the following purposes:

- A. To transact any and all lawful business.
- B. ARTICLE IV POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.



ARTICLE V CAPITAL STOCK

- A. The corporation is authorized to issue 100 shares of \$1.00 par value common stock, which shall be designated as "common shares."
- B. Except as otherwise provided by law or in the bylaws of the corporation, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE VI ADDRESS

The initial street address of the principal and registered office of this corporation is 1616 Mayfield Avenue, Winter Park, Florida 32789, and the name of the initial registered agent of this corporation is Edward Vedrin. The Board of Directors may from time to time move the principal registered office to any other address in Florida or change the corporation's registered agent.

ARTICLE VII DIRECTORS

The business and affairs of the corporation shall be managed by a Board of Directors consisting of not less than one person. The number of directors may be increased or diminished from time to time by the bylaws.
