# ARTICLES OF INCORPORATION OF

#### T. K. Enterprises of Lee County, Inc.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of this corporation is **T. K. Enterprises of Lee County, Inc.** and its principal office and mailing address is: **9915 Tamiami Trail North**, **#2, Naples**, **Florida 34108.** 

# **ARTICLE II - NATURE**

The nature of the business to be transacted by this corporation is: general cleaning services.

To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds. To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities or other evidences of indebtedness created by any other corporation, and while owner of such stock, to exercise all rights, powers and privileges of ownership, including the right to vote such stock. To purchase its own capital stock from earned surplus.
