ARTICLES OF INCORPORATION  
A SMALL WORLD SCHOOL 2, INC.

ARTICLE I - NAME

The name of this corporation is A Small World School 2, Inc. The corporation's principal place of business and mailing address shall be 9401 SW 168th Street, Miami, FL 33157.

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

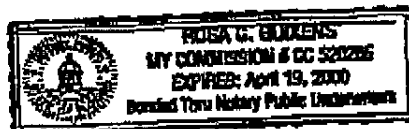
