

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is 5 STAR GATOR, INC.
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose(s) for which the corporation is organized are to buy and sell cars, to operate a cleaning service and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 1,000 Common Shares at No Par Value.
- FIFTH:** The corporation will not commence business until at least One Thousand Dollars (\$1000.) have been received by it as consideration for the issuance of shares.





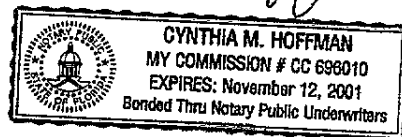
