

## ARTICLES OF INCORPORATION

#### Blackstar Real Estate, Inc.

SOME THE STATE OF The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### **ARTICLE I**

#### Name

The name of the corporation (hereinafter called the "Corporation") is:

#### <u>ARTICLE II</u>

#### **DURATION**

The duration of the Corporation shall be perpetual.
