

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is American Capital Mortgage Loan Corporation.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

ARTICLE IX - INDEMNIFICATION


The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


