ARTICLE I

CORPORATE NAME

The name of the corporation shall be

NAPA Roadside Assistance Inc.

ARTICLE II

DURATION

The corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

NATURE OF BUSINESS
