ARTICLES OF INCORPORATION
OF
LA DOLCE VITA, RESTAURANT OF MIAMI, INC.

The undersigned, a natural person, MICHAEL D'ANDREA, who is legally authorized to conduct business in the State of Florida, hereby intends to form a Corporation under the Florida Statutes and hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation is
LA DOLCE VITA, RESTAURANT OF MIAMI, INC.

ARTICLE II

The Corporation is a Florida Professional Service Corporation organized under Florida Statutes Annotated. The Corporation shall comply in all respects with that law, including the restrictions on who may be Shareholders and who may render professional services on behalf of the Corporation. The Florida Business Corporation Act, Chapter 607, Florida Statutes Annotated, shall apply to the Corporation.

ARTICLE III

The aggregate number of shares which the Corporation shall have the authority to issue shall be one thousand (1,000) shares of common stock at a \$.50 par value. All of said stock shall be payable in cash, patents, stock, notes, accounts, claims, real estate or other property or services at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.

ARTICLE IV

The street address of the Corporation shall be 1568 SPRINGSIDE DRIVE, WESTON, FL 33326. The name of the Corporation's registered agent is Suzanne Friedman, Esq. of the Law Office of Katz & Friedman, P.A. located at 100 S. Pine Island Road, Suite 114, Plantation, FL 33324, as its agent to accept service of process within Florida.

ARTICLE V

The number of directors constituting the initial Board of Directors of this corporation is one (1). The name and street address of the initial director of this Corporation is:

The initial director may serve from time to time and may, by resolution, fix the number constituting the Board of Directors and may also name the persons to fill vacancies on the Board of Directors created by an increase in the number of directors which occurs between annual meetings.

ARTICLE VI

The name of the incorporator is MICHAEL D'ANDREA, located at 1568 SPRINGSIDE DRIVE, WESTON, FL 33326.

ARTICLE VII

Anything to the contrary contained in these Articles of Incorporation notwithstanding, if the Shareholders of the Corporation shall so elect, they may exercise all powers and conduct the business and affairs of this Corporation in lieu of the Board of Directors.

ARTICLE VIII

Directors of this Corporation need not be residents of the State of Florida, unless otherwise provided in the By-Laws of the Corporation. The Shareholders of this Corporation shall have exclusive authority to fix the compensation of directors of this Corporation, unless otherwise provided in the By-Laws.

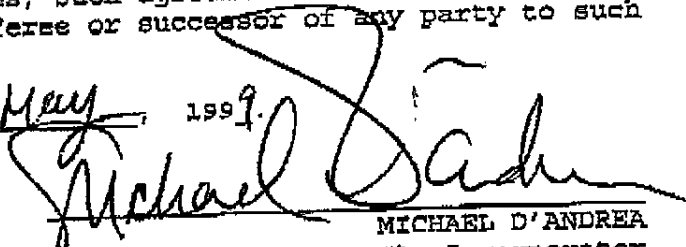
ARTICLE IX

ARTICLE X

The Corporation, its Shareholders, or any combination of the Corporation and its Shareholders, may enter into agreements limiting or restricting free transfers of shares of its capital stock. Any such agreements will be valid and enforceable among the parties to such agreements and, when the existence of such agreement is noted on the face or on the back of the certificates representing any such shares, such agreements will be binding and enforceable upon any transferee or successor of any party to such agreement.

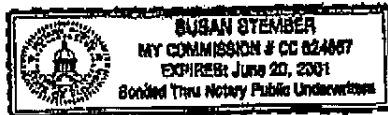
