ARTICLES OF INCORPORATION
(Professional Corporation)
OF
ROBERT R. WEAVER III, M.D., P.A.

The undersigned, all of whom are duly licensed to practice medicine, in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION: The name of the professional Corporation is **ROBERT R. WEAVER III, M.D., P.A.**

ARTICLE II - PURPOSE: The purpose for which the Corporation is organized to provide medical care and radiologic and related services.

ARTICLE III - ELECTION UNDER PROFESSIONAL CORPORATION ACT: The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

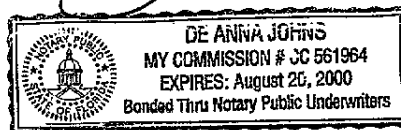
