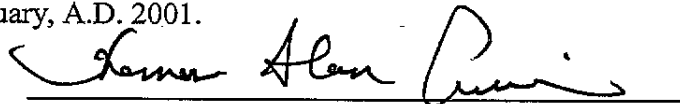

The name of the corporation shall be:

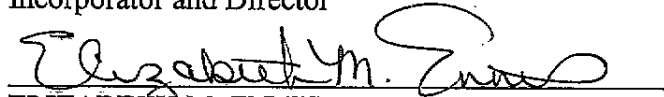

In all other respects the Articles of Incorporation remain the same as filed.

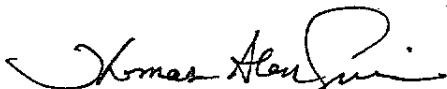
