ARTICLES OF INCORPORATION  
OF

The undersigned, acting as the incorporator of this Corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopts the following Articles of Incorporation:

ARTICLE I:  
NAME OF CORPORATION

The name of the corporation is: VICTOR A. POLITANO, M.D., P.A.

ARTICLE II:  
MAILING ADDRESS OF THE CORPORATION

ARTICLE III:  
DURATION OF THE CORPORATION

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE IV:

The general purpose for which the corporation is organized is to engage in any and every aspect of the practice of medicine in the specialty of Urology.

ARTICLE V:  
AUTHORIZED SHARES

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

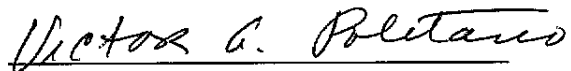
