ARTICLES OF INCORPORATION

of

**I Want Cookies Now, Inc.**

We, the undersigned, hereby declare the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be: I Want Cookies Now, Inc.

The general nature of the business of this corporation shall be all lawful business activity permitted under the laws of the State of Florida and under the laws of the United States of America, without exception. 
ARTICLE VIII






