

The undersigned subscriber to these Articles of Incorporation, Brigid D. Soldavini, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**CORPORATE NAME**

The name of this Corporation is GOT NO TIME, INC. The principal office and mailing address of the corporation is 5455 Jaeger Road, Naples, Florida 34109.

**ARTICLE II**

**DURATION**

The Corporation shall have perpetual existence, commencing upon May 19, 1999.

**ARTICLE III**

**PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV**

**CAPITAL STOCK**

The Corporation is authorized to issue 1000 shares of \$1.00 par value stock, which shall be designated "common shares." The stock of the Corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and all regulations issued thereunder. This Corporation is being capitalized and its stock is being issued to comply with the aforementioned section of the Internal Revenue Code.

**BY-LAWS**


The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the Shareholders in the manner provided by the laws of the State of Florida.

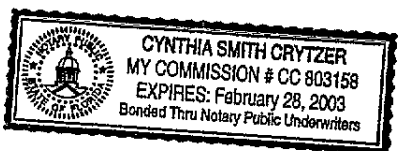
