**Article V – Capital Stock**

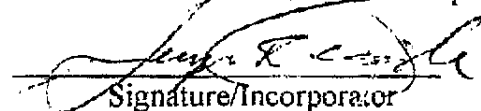
This corporation is authorized to issue fifty thousands (50,000) shares of .01 dollar par value common stock which shall be designated "Common Shares".

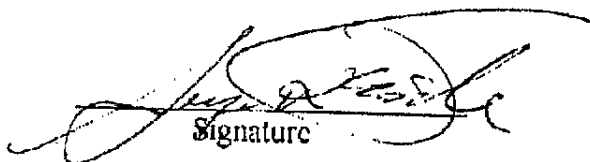
