## ARTICLES OF INCORPORATION EFFECTIVE DATE FABE, INC.

The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

#### ARTICLE ONE NAME

The name of the corporation is FABE, Inc.



#### ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.
