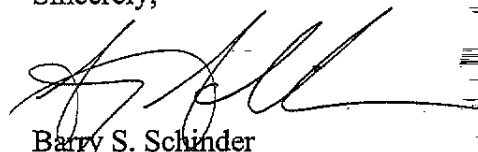

CORPORATE NAME
