The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: R. TODD GILLELAND, D.M.D., P.A., and the address is: 1980 S. Tuttle Avenue, Sarasota, Florida 34239.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. This Corporation is organized for the following purposes:

A. To engage in the practice of dentistry as a professional corporation and to own and operate a dental office for the purposes of providing dental and orthodontic care and treatment.

B. To treat, prescribe, diagnose, or operate for any disease, pain, injury, deficiency, deformity or physical condition of human teeth, gums, jaws, and adjacent tissues.

C. To furnish, construct, reproduce, or repair prosthetic dentures or bridges to be used and worn as substitutes for natural teeth.

D. To supply, repair, or construct orthodontic or various appliances used for the correction of malocclusion or deformities of other structures.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional dental or orthodontic services in the State of Florida.

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 1980 S. Tuttle Avenue, Sarasota, Florida 34239, and the name of its initial Registered Agent at that address is R. Todd Gilleland.

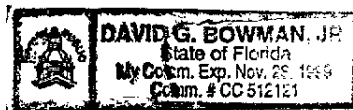

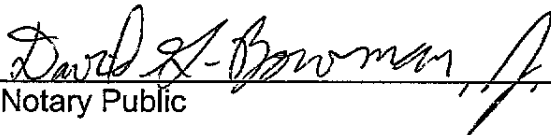
