ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Greer Companies, Inc.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

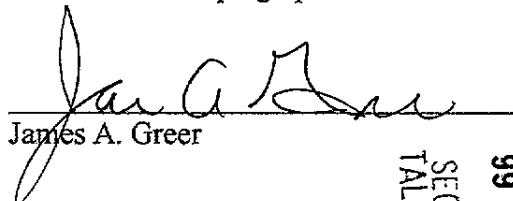
