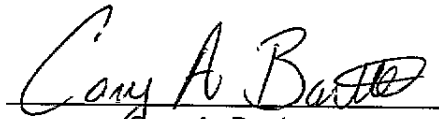

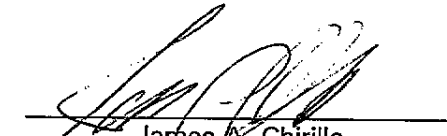
ARTICLE VII PURPOSE OF CORPORATION

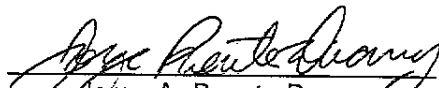
