



### AMENDED AND RESTATED ARTICLES OF INCORPORATION OF ... TELEINSIGHT, INC.



The Articles of Incorporation of TeleInsight, Inc. (the "Corporation"), originally filed with the Secretary of State of Florida on May 24, 1999, effective as of May 18, 1999, are hereby amended and restated in their entirety as set forth below. Pursuant to Section 607,1007 of the Florida Statutes, these Amended and Restated Articles of Incorporation were authorized by the Corporation's Sole Director and the Shareholders on January 12, 2000.

### ARTICLE I NAME

The name of the corporation is TeleInsight, Inc.(heremafter called the "Corporation").

### ARTICLE II MAILING ADDRESS

The principal place of business and mailing address of the Corporation is 120 Steeple Chase Circle, Suite 202, Sanford, Florida 32771.

### ARTICLE III CAPITAL STOCK

The number of shares of stock that the Corporation is authorized to issue is ten thousand (10,000) shares of common stock, at a \$.001 par value (the "Common Stock"). Each issued and outstanding share of Common Stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders of the Corporation.

### ARTICLE IV REGISTERED OFFICE AND AGENT
