ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TAKE CARE OF MANATEE, INC.

- Articles of Incorporation for TAKE CARE OF MANATEE, INC., were filed with 1. the Department of State on May 24, 1999, under document number P99000048007.
- Article IV of the corporation's Articles of Incorporation is hereby amended 2. provide as follows:
