The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) Shares of no par value stock.

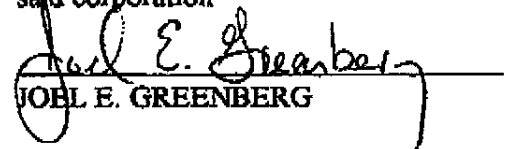
ARTICLE V

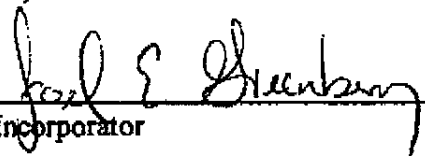
ARTICLE VIII
