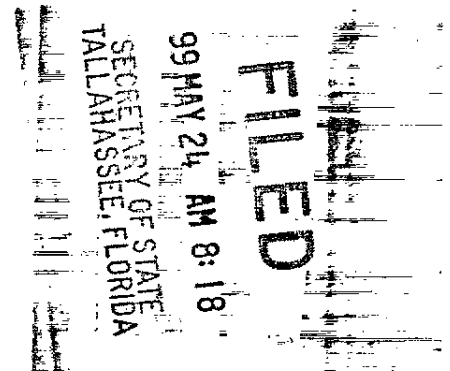

**ARTICLES OF INCORPORATION
OF
H AND J LEISURE TIME, INC.**

ARTICLE I. NAME

The name of this corporation shall be H and J Leisure Time, Inc.

ARTICLE II. DURATION

1. This corporation shall have perpetual existence.
2. This corporation shall commence to exist on the date of filing.

ARTICLE III. PURPOSE

This corporation shall be organized for the following purposes:

1. To operate a cruise travel agency.
2. To do any and all things with any and all powers to the same extent as natural persons might or could do.
3. To transact any and all lawful business.

ARTICLE IV. POWERS

This corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act.

ARTICLE V. PRINCIPAL OFFICE

The street address of the initial principal place of business and mailing address of this corporation shall be 1045 Twin Oaks Cr., Oviedo, Florida 32765.

ARTICLE VI. CAPITAL STOCK

1. This corporation is authorized to issue one thousand shares of \$1.00 par value common stock, which shall be designated "common shares."
2. All said stock shall be payable in cash, property (real or personal), labor or services in lieu of cash, at such valuation as may be fixed from time to time by the Board of Directors of this corporation.

ARTICLE VII. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.

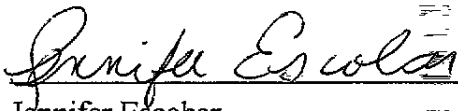
ARTICLE XIII. MEETINGS

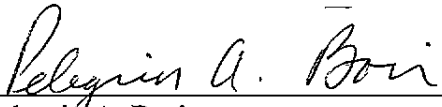

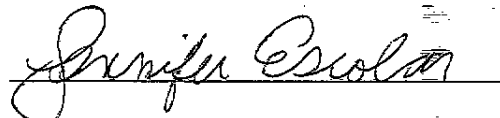
