ARTICLE - NAME

The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

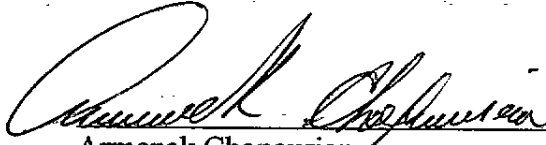

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto.

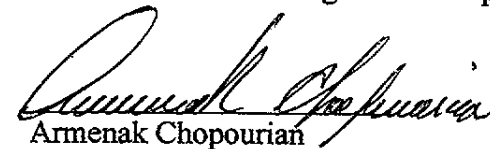

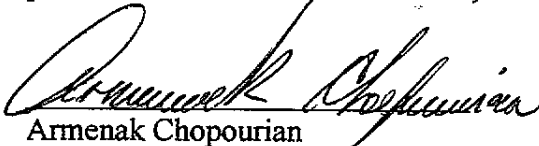
