ARTICLES OF INCORPORATION OF LATIN AMERICA INTERNET PARTNERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME
