ARTICLE I - NAME

The name of this Corporation is ORLANDO MATERIALS, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing  
on May 24, 1999.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted



This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida General Corporation Act.




