Pursuant to the provisions of Section 607.1005 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is TELEFONICA INTERACTIVA USA, INC. (the "Corporation"), Charter #P99000048283.

2. Given that the Corporation has not yet issued any shares, the following Amendment to the Articles of Incorporation was adopted by the written consent of the Sole Incorporator of the Corporation dated as of July 30, 1999, pursuant to the authority contained in Section 607.1005 of the Act.

3. Article VI of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article VI, as follows:

"ARTICLE VI

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of directors constituting the Board of Directors is one (1), and the name of the member of the Board of Directors, who is to serve as the Corporation's director until successors are duly elected and qualified is:

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. The effective date of this amendment shall be upon the filing of these Articles of Amendment.
