Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is TELEFONICA INTERACTIVA USA, INC. (the "Corporation").

2. The following Amendment to the Articles of Incorporation was adopted by the unanimous written consent of the Directors of the Corporation and the Shareholders of the Corporation, the number of votes cast being sufficient for approval, as of December 31, 1999 in the manner prescribed by Section 607.1003 of the Act.

3. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article I, as follows:

**"ARTICLE I**


The name of the corporation is "TERRA NETWORKS USA, INC."
