5. SAINTS WINCOV, INC. satisfies the requirements of the Florida Statutes 607.0401.

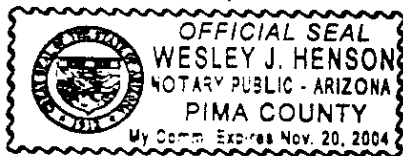
6. No further ground or grounds exist for the administrative dissolution of the Corporation.
